

We take a comprehensive approach, delivering the appropriate services and resources that justiceinvolved individuals need to develop and maintain long-term habits of success, while driving systemic change in the criminal justice system through education and collaboration. By integrating underutilized public health approaches and community resources, we provide the knowledge, expertise, and dialogue necessary to implement interventions that significantly improve outcomes.

### MESSAGE FROM OUR FOUNDER

2024 was a year of great growth, inspiration, and success for A Curiae. There were various events and conferences that allowed us to share our expertise and experience in the reentry space through an academic and direct services lens. I was overwhelmed with the desire to help through our volunteers, our growing board, and supportive agencies and organizations that have influenced the organization. Even as our team evolves and the landscape shifts, I am regularly reminded how important and impactful the work of A Curiae is and to keep our vision of serving both the reentry population and the courts throughout the criminal justice system to improve outcomes.

One of my goals in developing A Curiae was to invest in the reentry population, both through direct services and ultimately by providing employment opportunities for collaborative court graduates. We were able to do that this year, in a small capacity, by hiring Stephen Asmus who has served as the Policy and Community Associate in the Northern District of California. He went above and beyond in his role, building relationships with and providing direct services to participants through case management. He has been instrumental in conducting outreach and improving the organization, the collaborative courts, and how we approach stakeholders and colleagues to showcase our work. Stephen was accepted to multiple graduate programs and will begin one in the Spring of 2025. We want to wish him the best and thank him for his work with the organization. We hope he returns in the future to continue his amazing work with the courts.

From the beginning, mentors advised me to surround myself with smart and driven people to help with my organization. Each meeting, check in, and conversation with my board members, advisory board, and staff, I am reminded how talented, brilliant, and inspirational each person is to A Curiae. # WHAT WE DO

#### **Resource Referral Assistance**

By building a network of community providers, A Curiae works with clients to understand their social determinants of health, medical and therapeutic history, and previous experiences in treatment to find not just any programming but the correct programming.

#### **Professional Mentorship Initiative (PMI)**

Our program matches clients to professionals from various tech companies to mentors to work on professional skills, growth, and development. The program began in 2020 and has expanded to 5 districts, helping nearly 50 clients receive individualized mentorship.

#### **Financial Assistance**

A Curiae provides support to remove barriers for clients on supervision, covering the cost of items such as government or housing application fees and workplace support. In collaboration with the clients and their officer or court program, we create a plan that incentivizes financial assistance, fulfilling eligible requests after a client has completed their individualized requirements, such as consecutive negative urine analysis tests or beginning a community-based program.

# MEASURING PROGRESS

A Curiae worked diligently to provide direct services to the reentry population. With **53 intakes** this year, we touched base with clients to provide support and understand their needs. Working with their officer, A Curiae was able to connect with their respective officers or court contacts to be referred to the appropriate service.



# STORIES OF CHANGE

We were able to look for more ways to bring in academia, expertise, and community to the work of A Curiae in 2024. You can see a few highlights from our relationship with the School of Nursing Health Professionals at the University of San Francisco through our first Master's of Public Health Intern, Mikayla Aubry. One of our collaborative court graduates will shares his story along with his partner about the impact the program had for their family. And lastly, we were delighted to bring together staff and participants for a volunteer session at the San Francisco Food Bank in lieu of a traditional court setting.




Volunteer Day



# PARTNERSHIPS & COLLABORATION

#### Jesuit Prison Education Network (JPEN)

A Curiae has been collaborating with JPEN for the past few years, a group working to implement inside out prison education. These programs go into prison institutions to teach courses where incarcerated students can earn college credits. The hope is to build a sense of purpose while they are incarcerated and build a long term commitment to education upon release. These programs not only benefit incarcerated students but also provide professional development for correctional officers and offer unique learning experiences for university professors.

JPEN held two large events this year. The first was held at Loyola Chicago where we were able to share a book of essays we collectively wrote, "<u>Making the Case for Jesuit Prison Education.</u>" It was amazing to represent the University of San Francisco for this work, and a very special thank you to Stephen Asmus for coauthoring our essay for the book. The second event was a gathering at Notre Dame in South Bend Indiana. It was two days of incredible presentations, diligent networking and information sharing, and vision casting to strategize how to implement more impact and collaboration moving forward.

I want to thank Father Tom Curran who has led JPEN in developing partnerships and a network of passionate individuals to help the reentry population. His mentorship has been instrumental in shaping A Curiae's core values: prioritizing people, fostering strong stakeholder relationships, and cultivating professional growth. #### **Oral History Project**

# LOOKING AHEAD

We will also continue to refine our service objectives, with a goal of serving **40 unique individuals** in 2025. Those clients will continue to receive community-based resource referrals, be matched with professional mentors, and receive financial support as needed. We hope to expand to an additional **3 districts** in the coming year.
